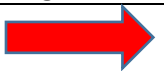

I _____ a Parent's/Guardians of Players (User's) hereby confirms and will acknowledges that the use of the Facility involves inherent risks, dangers and hazards including but not limited to collisions with structures or objects activities within one's own ability, negligence on the part of the Facility or its staff, and the User freely acts and assumes all such risks, dangers and hazards and the possibility of personal injury, death, property damage or loss resulting there from.

In consideration of the City of Lethbridge permitting the User to use the facility Civic Ice Centre the User(s) agrees to the following:

1. User does hereby release and forever discharge and agrees to indemnity and save harmless the City of Lethbridge, the councillors, officers, executive, directors, officials, employees, agents, servants and representatives, INCLUDING LETHBRIDGE & AREA RECREATIONAL HOCKEY CLUB executives, directors, coordinator(s), officers, volunteers, employees, agents, volunteer Coaches, servants (hereinafter referred to as "the Releases") from and against all claims, actions, costs, expenses, (including legal expenses and costs on a solicitor and his own client basis) and the demands made by anyone in respect to death, injury, loss or damage to any person or property, however caused arising out of or in connection with or during the use of the Facility and not withstanding that the same may have been caused by, contributed to or occasioned by the negligence breach of a contract, breach of a common duty of care as and occupier of premises, or otherwise of or by the Releases or any of them.
2. The User waives and all claims the User has or may have in the future against the Releases.
3. The User agrees to assume ALL RISK, both known and unknown, and all consequences thereof, arising out of or in connection with the use Facility - Civic Ice Centre.
4. The User, including its officers, volunteers, agents, employees, invitees, officials, players, coaches, trainers, and contractors will adhere to all rules, regulations, policies and conditions regarding the Facility Civic Ice Centre as exist from time to time.
